Mr. Cook reported that the Race Point is in Drydock at Thames Shipyard and there is every expectation that the project deadline will be met. Mr. Cook also reported that B&W and the Bike Path organization had asked about renting space at the South beach parking lot for staging and material storage for the West End Bike Path project. A vigorous discussion ensued that the last price could be developed. It was also agreed that only after contractor bids were made would the Ferry District discuss pricing discounts for island charity projects.

Mr. Cook reported that the annual NYS harassment training was going on well. The Ferry is using an online course to comply with NYS requirements. Chairwoman Burnham reminded Mr. Cook that the requirement is for all employees and we must be sure that the summer staff takes the course. It has been added to the orientation program for all new and returning employees. Commissioner Cashel recommended another affordable on-line solution (Tom can you forward me the coordinates?) which has a broad HR catalogue.

Commissioner Ahrens commented on Commissioner Cashel's edits on the District's 2020 year in review report that will be made available to the public. The edits were great and agrees that the BOC should not promise pricing changes but will be reviewing pricing from time to time.
