Management Reports

MU/RP/Silver Eel Updates - Mr. Haney updated the BOC. Trips are being added on Tuesdays and Thursdays to better manage commercial traffic needs until MV Race Point comes back. An extra boat was

added today. Race Point remains at the yard. There is still a bit of finish work to complete. Currently Thames Shipyard is working on repairing some of the fuel line after a fuel shut off valve was found leaking. The crew continues to work on painting. The USCG said that most approvals can be completed by the end of next week. This does not include the electrical approval. The District is hopeful that the boat will be back by May 15, 2021. Mr. Haney continues to wait on a return call from Yamaha regarding the engines for MV Silver Eel. The engines were expected the week of April 12, 2021, but still no word. Mr. Haney will continue to follow up.

Airport Repaving - Mr. Cook reported that the airport repaving will be starting next week, and work should be completed within a week. The pavers will be using North Star. The BOC has agreed to waive the touch fee.

Port Security Grant - Mr. Haney updated the BOC. Total Security completed the Race Point and the New London terminal. Fishers Island is in progress and should be completed within the next two days. Once Race Point is back, Total Security will complete Munnatawket.

Norton Fair Abatement - A letter was received from Mr. Glen Norton requesting a medical fair abatement. The BOC has approved.
