Management Reports

Race Point Update - Mr. Haney updated the BOC. There was a 45 minute delay on the 11:30 boat on Thursday, February 24, 2022 due to some necessary maintenance that went longer than expected. Maintenance included replacing the turbo, taking care of some life rafts and a boiler cleaning that is now a USCG requirement. Mr Haney continues to work on putting the Race Point yard package together that will take place later in the year. Mr. Haney is trying to reach out to a HVAC gentleman for a consultation regarding the boats heating and cooling which would determine the types of windows and doors needed. Mr. Haney has not received any response via email or phone as of yet but will continue to try. The USCG 5 year inspection is coming up on Monday, March 28, 2022. The 5 year inspection is much more involved and Mr. Haney was concerned about interruption in service due to having only one boat available at this time. He expressed his concern to the USCG and the USCG stated that most of this inspection could be done while underway and the times between 9am to 11:30 am would be enough time to complete the inspection an not effect service.

Munnatawket Update- Mr. Haney updated the BOC. Mr. Haney visited the shipyard today to inspect the haul plate repairs. The USCG completed their haul plate inspection today so Mr. Haney knows exactly how much haul plate will need replaced. Once the haul plate is replaced it will need to be pressure tested and 3 coats of paint applied before going back into the water. This should take place at the beginning of next week. Anchor Insulation will be coming this Thursday, March 10, 2022 to finish the insulation. Mr. Haney is planning for a USCG inspection the first week of April 2022. Mr. Franco has updated all 4 heads on the boat and has installed more electrical outlets in the cabin. There are now charging sockets between every seat. Mr. Haney will continue on getting an approximate cost from the shipyard. Life jackets will be evenly distributed with 100 on the upper deck storage, 50 in the bow boxes and 75 on the vehicle deck.

Other - Mr. Haney reported that he is preparing a summer schedule and looking at staffing needs. The intent is to have one summer schedule that goes from May through September 2022. The District will be losing 2 part-time positions and 1 full-time position that will be going to part-time. Mr. Haney has put out several ads online including Craigslist, Facebook and the Fishers Island Website and will plan to visit some area High Schools and talk to advisors to gain interest. Currently all positions are available.
