Management Reports

Race Point Update - Mr. Haney updated the BOC. Mr. Haney checked in with Twin Disc this morning to see if they were moving along with a DVTP for an emergency helm station up in the bridge. Twin Disc was looking into it. Mr. Haney also reported that in anticipation for the upcoming yard package for the Race Point, he has been ordering anything that would have an unusual lead time. The windows have been approved by the USCG so management will just have to pick the style of window that they want.

Munnatawket Update - Mr. Haney updated the BOC. Currently the crew is finishing painting projects; however, the boat is available if needed and the smaller boat will be used if the manifest dictates, as it uses less fuel. Commissioner Cashel asked if management thought the pricing was right for the larger trucks given the extra wear and tear. Mr. Haney does not feel the Ferry District is charging enough but understands the costs associated with an aging boat. Mr. Haney has agreed to look at the pricing a little closer. Mr. Cook reported that a representative from Elliot Bay Design Group will be joining them to ride the ferry on May 11, 2022.

Silver Eel Update - Mr. Haney reported that he called Yamaha and there is still no tracking information available on the backordered engines.

Other - Mr. Haney reported that the Captains are requesting that the 25-minute rule be moved to 30 minutes. Discussion ensued. Management will look into it more closely before the BOC makes a decision but appreciates the Captain's concerns.

Traffic - Mr. Haney reviewed March 2022 Traffic. Overall, passengers, vehicles and commercial traffic was down 1%, 13%, and 2% respectively compared with March 2021. Overall on time percentage is up 3% compared to March 2021.

Other - Mr. Cook reported that the RFPs for the Theater roof and the Airport painting are out and both are due next Tuesday, May 10, 2022. Commissioner Ahrens reminded management of the Blood Drive that is taking place on Fishers Island on June 3, 2022. Mr. Haney has been in contact with Mrs. Jane Ahrens and is willing to make any arrangements to get the phlebotomists off the island. Chair Burnham reported that the plants for ferry park have been ordered and will be planted in the near future.
