Race Point Update - Mr. Haney updated the BOC. A shipyard visit by Goodison took place last Thursday. Everything went well with some edits to the RFP. The shipyard RFP is due on October 19, 2022. Some work was done to one of the engines by a Rocky Hill marine technician.

**Munnatawket Update -** Mr. Haney updated the BOC. The safety orientation for the FIS students was held last week and went very well.

**Silver Eel Update** - Mr. Haney updated the BOC. The season came to an end on October 9, 2022. The boat will remain at the New London terminal and can be hauled out in two weeks by City Pier.

Traffic Update - Mr. Haney reviewed September 2022 traffic. Compared to September 2021, passengers were down 1%, vehicles up 3%, and Commercial up 21%. The Winter schedule starts this Thursday, October 13, 2022 and runs through April 5, 2023. The schedule is the same as last winter with no 11:30/12:45 on Wednesdays due to fuel charters. Mr. Haney sent two proposed 2023 summer schedules to the BOC. One version is with a freight boat. Commissioners were asked to send their comments to Mr. Haney.

**New London Sewage Disposal Invoice** - Mr. Cook included the invoice in the board pack as proof that the ferry district does dispose of sewage with the city of New London. Mr. Haney reported they have good records when the boats are pumped.

**Conference Summary** - Mr. Cook provided the BOC with a conference summary from a conference he attended in Seattle. Mr. Cook has requested a proposal from Elliot Bay Design Group and should have by the next BOC meeting. In addition Mr. Cook has a scheduled call this Friday with GNA who does a lot of marine grant writing.
