Financial Review - Carol Murphy reviewed financial statements through 9/30/22. Discussion ensued regarding Star Computers. The current Warrant included close to \$14,000 to Star Computers. This included the purchase of new servers. Carol Murphy reported that hourly fees have also gone up approximately 18% and the District was not notified of this increase. Ms. Murphy will be looking into the matter as to why the District was not notified and the ability to negotiate. The Budget to Actual is on target. As of October 23, 2022, Car & traffic revenue is at 100% of the 2022 budget. Expenses are in line with Revenue. A \$425,000 appropriation was made from the fund balance to cover the increased fuel costs and excess repairs on all three ferries. Cash Balance is at \$2.3 Million and all taxes are in. Carol reported that the District has remained constant with the fuel surcharge at 5% compared to other ferries. Management will continue to monitor fuel costs.
