# **Management Reports**

**Ticketing -** Mr. Cook reported that he has been working with Fair Harbor regarding the ticketing system and scanning capabilities.

**Elliot Bay -** Mr. Cook reported that Elliot Bay will be visiting on December 12-13, 2022. Mr. Cook will get the word out to local businesses and the public.

**Airport by the Numbers** - Mr. Cook compiled a brief look at the Airport by numbers for 2021. He has agreed to compile the 2022 data for the 4 summer months and will share on the ferry website and the Fishers Island website.

**Traffic -** Mr. Haney reviewed October 2022 Traffic. Passengers, Vehicles and Commercial traffic were up 1%, down 7% and up 9% respectively from 2021. On time percentage was at 96%. 4 boats were added to the Columbus Holiday schedule. Mr. Haney reported that they will be adding later boats in the months

of January and February for the ski club and is willing to add another late boat in December if people want it for shopping, etc.

Race Point/Munnatawket Update - Mr. Haney updated the BOC. Race Point is scheduled to go to Goodison Shipyard the week of January 2-6, 2023. Goodison did receive the contract last week and Mr. Haney is waiting to hear back from them. The yard package is expected to last 8 weeks. The manufacturing of the windows is currently pushed back by two weeks. Munnatawket has a few more maintenance issues to complete. The cancelled trip on November 11, 2022 were due to hard southerly winds which makes for difficulty docking the boat in New London. Mr. Haney reported that the excursion permit was denied by the USCG. Mr. Haney has reached out to a gentleman from the PVA conference to see if he can assist at all with this issue.
