Why were the rates and scheduled changed? To help increase revenues.

When will the petitions be ready for the upcoming election. Next week.
Who is eligible to vote? Property owners and electors of the last Southold election.
Are there any term limits for commissioners? No.
Is it possible to put financial info on the website? We will ask the Town Comptroller.
Is it possible to put meetings and minutes on the website? Yes, we will attempt it.
Can you change the Budget Hearing to 5:00 PM. Yes, we will do that.

- 4. The Manager submitted the ridership numbers for the month of June plus a full Excel Spreadsheet comparison to the previous year.
