## **Tri-Axle Charters:**

A discussion followed regarding:

- Appropriate touch fee rates for excessive weight trucks arriving on and departing from the island
- Resulting wear and tear on the ramps
- Means by which weights can be confirmed particularly on equipment weighing in excess of 80,000 lbs., the legal weight limit on Connecticut roads.

Management will put together a proposal for rates on heavy load touch fees and check with ramp engineers on the maximum weight the three Ferry District ramps can take.

## 2014 Conservancy/Ferry District Grasslands Goals:

Mr. Lamb shared the goals for the Fishers Island Conservancy for 2014 sent for review by the Ferry District Commissioners. The Conservancy is budgeting \$35-\$40k and appreciates the support of the Ferry District in the Conservancy's plan and look forward to continuing to work with the District.
