Minutes of the meeting of the Board of Commissioners Fishers Island Ferry District July 20, 2015

A meeting of the Board of Commissioners of the Fishers Island Ferry District was called to order on July 20, 2015 at 4:30 PM by Commissioner Peter Rugg at the Fishers Island Community Center.

Present were Commissioners Ahrens, Rugg, and Parker. Present were Assistance Managers RJ Burns, Gordon Murphy, and Diane Hansen. Members of the Public included Peter Gaillard.

Commissioner Peter Rugg was nominated as meeting chairman and officially called the meeting to order at 4:30PM; everyone in attendance pledged allegiance to the flag.

A letter was sent to the ferry from George Guimaraes thanking the crew that volunteered to help provide transport to him and his wife a couple weeks ago. Richard Bartels, representing Goose Island addressed the fact that he does not want to have to charter an entire ferry to have gasoline, fuel, or oil sent over to the island. He would rather it just be carried on passenger ferries because he supplies on a seven day a week basis and it is costing his business too much.

Ferry Updates:

Last week there happened to be a car fire in the parking lot with no injuries or facility damage.

The engine on the Munnatawket has been replaced in a very smooth procedure and the Board wishes to thank all those who made this happen.

Fairhaven has been contacted in regard to an oil leakage on the ferry which turned out to be nothing serious. Replacements were made at no charge. Yard package has been started for next yard period. There were errors in last invoice but that too has been addressed and dealt with. Spare engine is in fact back home!

There was a problem with the wheel locking up on July 19, 2015, where the crew had to back into the slip and could not depart on time. The crew handled it wonderfully and made sure to notify passengers before they successfully fixed the problem.

As for deferred maintenance, two out of three AC units stopped working Friday in the NL terminal. Now they just have one in the ticket/waiting area working.

Fuel Transport

Going back to the public comments and the concerns voiced regarding the step to put all fuel transport on its own boat...the move the ferry made towards this was a necessary one. It is a case of insurance coverage. Anything flammable such as the oil, gas, fuel etc. can not be on a ferry with more than sixteen passengers.

Ideas were discussed regarding combining cargo only boats with flammable traffic in order to be more efficient and having two trips a week, one during a week day and one during a weekday evening.

After reviewing the relevant Federal regulations, guidance from the Coast Guard, the Ferry District's insurers and studying the practices of similar ferry operations, the Commissioners directed management to move fuel, other bulk hazardous material, and other cargo on non-passenger, cargo trips, at regular commercial tariffs, in order to comply with current and expected regulations and to work with all island vendors to minimize impact to their operations practicable. In addition, the Commissioners approved the purchase of new fire suppression systems for transport of these cargos safely.
