**FI Conservancy Update** – Chairman Ahrens recused himself from the discussion as he is a member of the FI Conservancy Board. Mr. Murphy reviewed with the BOC, the FI Conservancy's written plan of action for 2017.

## Conservancy

Resolution 2017-005

WHEREAS, the Ferry District manages the airport and parade ground lands and has previously contracted with the Fishers Island Conservancy to maintain trails and develop the grasslands within this area; and

WHEREAS, the Fishers Island Conservancy has again agreed to provide these services in 2017 as an independent contractor, at no cost to the FIFD or the Town of Southold, and

WHEREAS, the FIC has provided a 2017 Grasslands Management Plan to the BOC detailing the services to be provided in the coming year.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Commissioners of the FIFD approves the Fishers Island Conservancy 2017 Grasslands Management Plan and authorizes the Fishers Island Conservancy to carry out the Plan upon the provision of a Certificate of general liability insurance with limits of not less than \$1 million per occurrence and naming the Town of Southold and the FIFD as additional insureds, subject to the approval of Ferry District Counsel.

# **Management Reports**

RP Yard period – Mr. Burns updated the BOC on the progress of the Race Point. M Burns met with the US Coast Guard Inspector, the shipyard manager and welding shop foreman today and identified all work that needs to be done regarding the bottom plates. Mr. Burns reviewed photos that he sent to the BOC and will send out a more detailed update on Tuesday, Jan 10th, 2017. Mr. Burns requested a detailed estimate from the shipyard manager regarding the bottom plate work and should receive in the next two days. The BOC was updated on the completed work.

Mr. Burns reported that the FIFD Crew party is scheduled for January 14, 2017 at the Steak Loft in Mystic.

Mr. Burns reported that he received an estimate from Docko, Inc. for designing and permitting of a floating dock in Silver Eel Cove and will forward to the BOC within the next few days.

Mr. Burns reviewed the 2016 traffic numbers. New tracking codes have been developed to accurately reflect the on-time data.

### Fairhaven Amendment

**RESOLUTION 2017-006** 

WHEREAS, the BOC of the FIFD, by way of resolution 2106-210 dated November 8, 2016 (amended in part by resolution 2016-242 on December 21, 2106), accepted the proposal from Fairhaven Shipyard to conduct the required biennial US Coast Guard inspection and maintenance of the MV Race Point in the amount of \$187,510 with a contingency amount for additional repairs in the amount of \$37,490; and

WHEREAS, the MV Race Point was hauled out on November 28, 2016 for inspection and is currently undergoing inspection and repair; and

WHEREAS, the inspection has revealed maintenance items that were not foreseen when the Fairhaven proposal was submitted; and

WHEREAS the US Coast Guard has mandated that said repairs be completed before the MV Race Point can be cleared for passenger transport; and

WHEREAS, the additional repairs are estimated to cost \$20,000 more than the original contingency amount bid in the Fairhaven proposal

NOW, THEREFORE, BE IT RESOLVED, that the BOC of the FIFD approves the change in appropriations and amends the approved contingency amount from \$37,490 to \$57,490, with the total contract price not to exceed \$245,000.
