Management Reports

Race Point Update – Mr. Burns updated the BOC. Mr. Burns has been reviewing the changes in the stability letter with the captains. Mr. Burns has asked the architects for clarification regarding the vehicle count and weight distribution and is awaiting a reply. Mr. Burns has received confirmation regarding the number of passengers that could be carried in the event of an evacuation. Both vessels can successfully remove the entire winter island population and school in the event of an evacuation.

Mr. Burns stated that the Race Point is now considered a one compartment vessel and any one compartment of the vessel can flood, including the engine room and still remain afloat with a full load. This is a significant improvement in safety. The USCG Certificate of Inspection ("COI") is scheduled for Thursday, April 6, 2017. The compass will be calibrated on Wednesday, April 5, 2017. Mr. Burns received an estimate from Dockside Electronics to upgrade the electronics on both vessels. Current electronics are obsolete and any new equipment cannot be integrated with existing equipment and parts are no longer available

North Ramp Dolphins and Pilings Update – Mr. Burns informed the BOC that he is waiting for an update from Docko regarding the specifications of the project prior to the work going out to bid. Mr. Cook informed the BOC that the spoils from the dredging can be put on land at the USCG area of silver eel cove.

Passenger Ferry Update – Mr. Cook updated the BOC. The contract with Blackbird VII, LLC has been reviewed by counsel and the expected start date for passenger service is on or about April 15, 2017. The website is nearing completion to take online reservations.
