# Minutes of the Meeting of the Board of Commissioners Fishers Island Ferry District September 5, 2017

Commissioner Ahrens at the Fishers Island Community Center called to order a meeting of the Board of Commissioners of the Fishers Island Ferry District ("the Ferry District") to order on September 5, 2017 at 4:30 PM.

Commissioners William Bloethe, Heather Burnham and D. Shillo were present. Also in attendance were Gordon Murphy, Geb Cook, RJ Burns, Diane Hansen and Deanna Ross.

Commissioner Ahrens established that a quorum was present. Everyone in attendance pledged allegiance to the flag.

**Correspondence/Public Comment** – Mr. Cook received one email regarding a cancelled Hovercraft run due to weather but then running it because the weather improved and not notifying the initial passengers that were cancelled. Mr. Cook spoke with that customer and acknowledged the error. A letter was received from Friends of the Fisher's Island Theatre (FFIT) notifying the Board that they are in the process of obtaining 501(c)(3) status and expressing their desire to purchase the Fishers Island Theatre.

A letter of intent was received from Walsh Park Benevolent Corporation suggesting that they conduct a feasibility study for a long-term lease of the second floor of the freight building and constructing apartments that would meet the requirements of affordable housing.

# **Management Reports**

**SEC Dolphin Status -** Mr. Burns updated the BOC. The lack of progress is due to difficulty with the bottom. Management gave approval to the contractor to move some of the dolphins in order to get penetration of 12-20 feet. Estimated time of completion is the week ending September 15.

**Race Point Insulation** - Mr. Burns informed the BOC that RP will be dockside the last two weeks of October for the installation of the A-60 structural fire protection.

**Munnatawket Engines, Insulation and Yard Package** - Mr. Burns updated the BOC. MU will be out of service beginning the evening of September 6 so Fairhaven Shipyard can paint the car deck. During this MU dockside period, general maintenance will take place. School Safety Day is scheduled for September 14, 2017. The MU is available November 1, 2017 for her yard period. Anchor Insulation informed Mr. Burns that the price is the same whether the installation occurs at the shipyard or dockside; therefore, Mr. Burns will include the insulation installation in the yard package. As part of the yard specifications, the yard has nine weeks from the day of arrival to complete the work. The Yard Package will be advertised in the New London Day on September 6, 2017. All submittals are due by September 18, 2017. Contract award will take place October 16, 2017. The bids for the MU engines are due September 8, 2017. Once all submittals are received and after review by Gilbert naval architects, a bid selection will take place on September 15, 2017. Mr. Burns informed the BOC that the engine horsepower will remain the same and use the existing transmission and propeller shaft. The only variable is that the propellers may need to be re-pitched.

### **Race Point Insulation Award**

### **RESOLUTION 2017 - 155**

Whereas A-60 rated structural fire protection is required in the engine room of the M/V Race Point; and

Whereas a Request For Proposals was issued and advertised in a widely circulated publication; and

Whereas one proposal was received, the proposal conforms to the published specifications, the pricing is acceptable to management, and management recommends accepting the proposal from Anchor Insulation Company, Inc.; and

Whereas there may be unforeseen circumstances which require change orders, now therefore it is

Resolved that the Board of Commissioners of the Fishers Island Ferry District accepts the bid from Anchor Insulation Company, Inc. for \$44,722 to install A-60 rated structural fire protection in the MV Race Point; and be it further

Resolved to authorize management to review and authorize change orders up to \$4,472; the total cost not to exceed \$49,194.

It is further RESOLVED to authorize management to execute contract and ancillary documents for this project after review by District counsel.

**Floating Dock and Other Permitting** - Mr. Cook updated the BOC. Docko has been asked to submit proposals for permitting for a floating dock and dredging in Silver Eel Cove and dolphin repairs at the

New London Terminal. The BOC has agreed to move forward with the permitting for the dredging so as to be completed by spring 2018.

# Bonding

Resolution 2017 - 156

WHEREAS the MV Munnatawket runs on 1978 Detroit Diesel engines for which parts are difficult to obtain, making repairs problematic; and

WHEREAS the estimate for new equipment and labor to replace the engines and associated parts is estimated to be \$300,000; and

WHEREAS it is necessary to dredge the Silver Eel Cove channel to prevent the ferries from grounding, which channel was last dredged in 1992; and

WHEREAS the estimate to dredge and remove the material is \$100,000; and

WHEREAS, the Fishers Island Ferry District has determined that engine replacement and Silver Eel Cove channel dredging is required for ferry operations to continue safely and without interruption (the "projects"); and

WHEREAS, the Fishers Island Ferry District is responsible for the payment of the cost of the projects, and

WHEREAS, the Board of Commissioners of the Fishers Island Ferry District desires to finance the cost of the project through bonds, and, in the time before the issuance of bonds, through Bond Anticipation Notes ("Notes"); and

WHEREAS, the Town of Southold is authorized to issue Notes on behalf of the Fishers Island Ferry District pursuant to the provisions of Sections 25 and 39 of the Local Finance Law, Chapter 33-a of the Consolidated Laws of the State of New York, upon formal request of the Board of Commissioners.

NOW, THERFORE, BE IT RESOLVED that the Board of Commissioners of the Fishers Island Ferry District authorizes and directs Chairman Andrew Ahrens to submit a letter to the Town Board of the Town of Southold requesting that a Bond Anticipation Note Resolution be passed, in the form approved by Bond Counsel and the Town Attorney, at their next meeting authorizing the issuance of said Notes to finance the cost of the aforesaid projects.
