Management Reports

Marine Update - Mr. Burns updated the BOC. Mr. Burns will be meeting with the new Fishers Island USPS PPostmaster to discuss protocols for US mail. M/V Munnatawket is on track and scheduled to return on March 26, 2019. Mr. Burns would like to extend his compliments to Mr. John Paradis and Mr. Mike Franco. M/V Race Point has been operating well. Mr. Burns informed the BOC that consideration for a mid-life overhaul of the M/V Race Point is back on the table. The mid-life overhaul would include new engines, transmissions, generators and all associated systems. Mr. Burns will be meeting with one engine vendor this Friday and additional vendors next week. This would be a two-year project prior to implementation. Estimated cost is approximately \$1 million and would most likely require M/V Race Point to be out of service for 6 months. Mr. Cook is looking into-to MJ Bradley for assistance in finding a possible grant.

RESOLUTION 2019 - 027

WHEREAS, the Board of Commissioners of the Fishers Island Ferry District ("BOC"), in accordance with the provisions of the Enabling Act of the Fishers Island Ferry District, has the authority and duty to control and supervise ferry operations; and

WHEREAS, the BOC has identified the need to provide the residents and taxpayers of the District with a high speed passenger only trips New York and Connecticut and other services; and

WHEREAS, the BOC has previously received a proposal from Kirby Perkins Construction, Inc. ("Seller") for the sale of a twenty passenger certified ferryboat for the purchase price of \$460,000, with a refundable deposit of \$10,000.

WHEREAS, the BOC now wishes to proceed with a Bareboat Charter Agreement in anticipation of receiving bond proceeds that will allow for the execution of a Vessel Purchase Agreement towards said twenty passenger U.S. Coast Guard certified ferry boat.

NOW, THEREFORE BE IT RESOLVED, that the BOC authorizes and directs Ferry Manager Geb Cook to execute the Bareboat Charter Party Agreement and the Vessel Purchase Agreement subject to review and approval of District Counsel and the Town Attorney.

RESOLUTION 2019 - 034

WHEREAS, the Board of Commissioners of the Fishers Island Ferry District ("BOC"), in accordance with the provisions of the Enabling Act of the Fishers Island Ferry District ("District"), has the authority and duty to control and supervise ferry operations; and

WHEREAS, the BOC has identified the immediate need to provide the residents and taxpayers of the District with passenger only ferry service between Fishers Island, New York and New London, Connecticut; and

WHEREAS, the BOC has received a proposal from Kirby Perkins Construction, Inc. ("Seller") for the sale of a twenty passenger certified ferry boat named "Bangerang" for the purchase price of \$460,000, subject to the authorization of the Town Board of the Town of Southold for the financing of said purchase by way of municipal bonding; and

WHEREAS, pending the authorization and availability of funding for the purchase price, the Seller has agreed to grant a Charter Lease of the Bangerang to the District for a term not to exceed six (6) months and to apply the Charter payments to the purchase price of the Bangerang; and

WHEREAS, the BOC has determined that the Chartering and eventual purchase of the Bangerang is in the best interest of the District, its residents and taxpayers.

NOW, THEREFORE BE IT RESOLVED, that the BOC authorizes and directs Ferry Manager Geb Cook to execute a Bareboat Charter Party Agreement and a Vessel Purchase Agreement for an amount not to exceed \$460,000, subject to review and approval of District Counsel and the Town Attorney.

Property Tax Update - Mr. Cook informed the BOC that letters to lease holders would be completed tomorrowMarch 5th. Leaseholders will be invited to come to the next-BOC meeting on March 18, 2019 to address any questions or concerns regarding the new property tax. Commissioner Burnham asked if the Tax Assessor completed the new assessment allocation with current identified leaseholders. Mr. Cook stated that this should be finalized by tomorrowMarch 5th.

Theater Update - Mr. Murphy updated the BOC. Chris from BD electrician should have his report completed this week. Mr. Chris Finan has agreed to come to the next BOC meeting. To date, management has not gone forward with a FFIT Agreement to operate the theater for the 2019 season.

Dredging Update - Mr. Cook informed the BOC that the permit is for May 31, 2019. RFPs are being finalized. A projected start date is scheduled for mid to late April 2019. Dredging should take approximately 5 days and all spoils will be placed along the berm. Commissioner Burnham reminded the BOC and management of the need for a master plan for parking. Management will start identifying owners of vehicles in order to clear the lot in preparation for dredging.

2019 – 2024 ACIP - Mr. Murphy reviewed highlights of the rolling five year 2019 - 2014 Airport Capital Improvement Program (ACIP) for Elizabeth Field. Mr. Cook informed the BOC that he has spoken with Mr. Brad Burnham and he has expressed continued interest in moving forward with the hangar.
