Minutes of the Meeting of the Board of Commissioners Fishers Island Ferry District April 29, 2019

Chairman Ahrens, at the New London Terminal, called a meeting of the Board of Commissioners of the Fishers Island Ferry District ("the Ferry District") to order on April 29, 2019 at 1:45 PM.

Commissioners William Bloethe, Peter Rugg and Dianna Shillo were present. Also in attendance were Gordon Murphy, RJ Burns, Diane Hansen and Deanna Ross. There were several members of the public present. Commissioner Burnham was absent.

Chairman Rugg established that a quorum was present. Everyone in attendance pledged allegiance to the flag.

Correspondence/Public Comment – Commissioner Shillo received an email from Mr. David Rivers requesting a fare waiver so he can transport his disabled mother to the island where she will be met and picked up by her partner. Discussion ensued. Mr. Burns commented that the FD holds firm ground with regard to ADA compliance. ADA compliance applies to the terminals, not the ferries. Accommodations are made as needed. The BOC has agreed to accommodate Mr. Rivers request and will look at these requests on a case by case basis. Commissioner Shillo will respond to Mr. Rivers. Chairman Ahrens received a request from FIFD Assistant Chief, Matt Edwards, asking permission from the FD to use the bunker for training on May 18, 2019. The BOC approves Mr. Edwards's request. There was no public comment.

Management Reports

Marine Update - Mr. Burns updated the BOC. Mr. Burns is very pleased with Goodison Shipyard and their project manager and believes they did a fantastic job with the re-power of Munnatawket. Electronic testing protocols and sea trials were successful. Currently the results are in the hands of the USCG awaiting approval. Mr. Burns does not have an ETA; however, feels the process will be completed soon. Fairhaven Shipyard arrived at the New London Terminal this morning to replace the wheelhouse windows. The delay was due to the manufacturer of the windows. Goodison Shipyard will be arriving this week to complete the punch list from the shipyard. There is no additional cost associated with this work. Cummins and possibly Twin Disc are expected to arrive tomorrow with the new black box and program it into the new control systems. Training of the captains and crew will continue. COIs for both boats are scheduled for mid-May. Painting of the boats will take place as weather permits. Once Munnatawket is up and running, Race Point will go offline for maintenance before the peak season arrives. Commissioner Shillo inquired about a diver she observed at the dock. Mr. Burns responded that the FD adopted the same protocol as Cross Sound Ferry and have a diver come out once a week to inspect and clean the keel cooler, etc.

Fast Passenger Ferry Update - Mr. Burns is focusing on the operations/support of the boat. Mr. Burns and Mr. Haney have been looking for fuel vendors and have found one. In addition, Mr. Burns is awaiting an email back from Norton's Marine to work towards a maintenance contract for the outboards. A name change of the boat will occur through a contest. Mr. Burns has asked that the name be picked out soon as the name will have to be changed with the change of documents and COI. Mr. Murphy reported that he is waiting to hear back from the TOS regarding the loan. Docking is secured with New London City Pier and FIDCO. There has been ongoing discussion of tentative schedules and staffing.

Property Update - Walsh Park/Freight Building - Mr. Murphy reported that no final decision has been made with regard to the fire suppression system. The sub-committee will be meeting this Friday. Mr. Cook or Chairman Ahrens will report back to the BOC after the meeting.

Theater Update - Mr. Murphy reported that the FD will be negotiating with the Friends of Fishers Island Theater for an annual lease. There is nothing finalized at this time.

HANGAR PROJECT AGREEMENT

RESOLUTION 2019 - 067

WHEREAS, pursuant to Section 5-b(g) of the 1947 Enabling Act of the Fishers Island Ferry District ("FIFD"), the Board of Commissioners is authorized to manage and operate the Elizabeth Field Airport ("Airport") and to lease a portion of the Airport premises as may be reasonably necessary or incidental to the repair and operation of aircraft and the use and operation of the Airport, subject to the approval of the Town Board of the Town of Southold following a public hearing held by the Board of Commissioners of the FIFD; and

WHEREAS, the Board of Commissioners of the FIFD has recognized the need for an airplane hangar for the maintenance and storage of aircraft utilizing the airport; and

WHEREAS, the BOC of the FIFD has received an offer from 39 Bravo LLC for a ground lease of up to thirty-five (35) years of a portion of the Airport premises and for the design and construction of a three (3) airplane hangar upon said premises at no cost to the residents of the FIFD (the "Project"); and

WHEREAS, the BOC of the FIFD held a duly noticed public hearing on May 29, 2018 for the purpose of presenting the project to the residents of the FIFD and to invite comment from all interested persons; and

WHEREAS, no public comment was offered at said hearing in opposition to the Project; and

WHEREAS, the BOC of the FIFD has determined that it will be in the best interests of the resident of the FIFD to proceed with the Project; now, therefore, be it

RESOLVED that the Board of Commissioners of the Fishers Island Ferry District hereby authorizes and directs management, to execute the Hangar Project Agreement and Ground Lease with 39 Bravo, LLC, subject to the approval of District counsel, the Town Attorney and the Town Board.

Mr. Murphy reported that Mr. Cook is looking into different techniques including hydraulic dredging as opposed to the clam shell.

New London Seafood - Mr. Burns reported that he has been in constant communication with the fishing vessels and they have been dropping their catch off. Commissioner Shillo has requested management to provide revenue numbers associated with the fishing vessels.
