Minutes of the Meeting of the Board of Commissioners Fishers Island Ferry District May 13, 2019

Chairman Ahrens, at the Fishers Island Community Center, called a meeting of the Board of Commissioners of the Fishers Island Ferry District ("the Ferry District") to order on May 13, 2019 at 4:30 PM.

Commissioners William Bloethe, Heather Burnham and Dianna Shillo were present. Also in attendance were Geb Cook, Gordon Murphy and Deanna Ross. RJ Burns was present via telephone. Commissioner Peter Rugg was absent. There were no members of the public present.

Chairman Ahrens established that a quorum was present. Everyone in attendance pledged allegiance to the flag.

Correspondence/Public Comment – Mr. Murphy reported that the FD received an email from IPP requesting a student rate for a 15 year old off island student who will be working as a counselor at IPP for the summer. The BOC has granted the request and Mr. Murphy will respond. There is no public comment.

Finance Committee - Mr. Cook updated the BOC. Financials were reviewed during the working session. Car and Traffic is down 15%. Gross profit is down 4%. Total expenses are down 9% year over year.

Management Reports

Marine Update - Mr. Burns updated the BOC. Munnatawket's COI is this Friday, May 17, 2019 at 9am. A few details remain prior to the COI. Race Point's COI is scheduled for Tuesday, June 4, 2019. All the captains are comfortable with the maneuvering of Munnatawket with the new engines. To date, there has been a saving of 12 gallons of oil per engine. Mr. Burns will be able to quantify the fuel savings at a later date when the boat has been running more. Mr. Burns visited New London City Hall this morning to provide them with information on the new passenger ferryboat. City Hall has shown great support in the endeavor. Mr. Burns also visited the New London dock master to discuss slip rental details. Mr. Burns is grateful for the team effort of the City, as well as the USCG in Rhode Island and Connecticut. Mr. Burns believes that the passenger ferry boat will not be available until after Memorial Day. Once the boat arrives, a USCG "new to zone inspection" will need to take place prior to operation of the boat and several days will be needed to familiarize the captains and crew with the boat. The Harbor Elementary School will be taking a field trip to Fishers Island School on June 4, 2019. 38 students plus chaperones will pay student pricing. Mr. Burns notified the BOC that a small disturbance by a suspected mentally ill person occurred in the lobby of the New London Terminal last Sunday. The incident was handled very well by Steve Conary. New London EMTs were notified and responded to the individual and the entire incident lasted no more than 10 minutes.

Property Update - Mr. Murphy informed the BOC that in preparation for leasing 357 Whistler Avenue to Hay Harbor for dates, the FD is looking for furniture to furnish the house. Rental permitting is in process with TOS.

Passenger Ferry Update - Mr. Cook updated the BOC. The Town of Southold offered a short-term loan of \$460,000 at 2.5% interest per year. Management expects to pay this off in September 2019. The invoice was received from Kirby Perkins and is on the warrant approved today. Management expects to take possession of the boat either Thursday, May 23, 2019 or Friday, May 24, 2019. Several captains have visited the boat and have test-driven her. Several scheduling conference calls have taken place with FareHarbor. Presently, there are a total of 18-20 scheduled trips per week. Trips are coordinated with the trains. This will be a focused reservation boat. Commuter pricing which will be purchased in 20 ticket bundles at \$21.00 round trip. Non-commuter passengers with a reservation will pay \$15.00 plus service fee for one way. Walk-ons will pay \$18.00 plus service fee one way. Management continues to work on scheduling and rates and both are subject to change. These prices differ from those previously reported.

Theater Update - Mr. Murphy sent Mr. Luke Fowler, president of Friends of Fishers Island Theater, Inc., a draft lease with a yearly \$1,000 fee plus utilities and it was rejected. The FD paid \$5,000 into maintenance of the roof last year. In addition, the FD paid for maintenance of the projector and paid offseason utilities including a \$1,200 energy audit by BD to help resolve the electrical issue. The FI School notified the FD that they would like to use the Theater for graduation. Discussion ensued. Management will continue to work towards a solution.

RESOLUTION 2019 - 078

Whereas the District has entered into a Purchase and Sale Agreement with Kirby Perkins Construction, Inc. for the acquisition of a passenger ferry; and

Waive procurement for passenger ferry fuel

WHEREAS THE BOC OF THE FIFD HAS DETERMINED THAT IT WOULD BE MORE EFFICIENT AND COST EFFECTIVE TO COMPLETE THE REPAINTING OF THE ENTIRE VESSEL BOTTOM AT THIS TIME TO SAVE THE COST OF PATCH PAINTING; AND

WHEREAS, THE PAINTING OF THE VESSEL BOTTOM WILL EXCEED THE APPROVED CONTINGENCY AMOUNT BY \$34.000: AND

WHEREAS, J. GOODISON CO., INC. HAS PRESENTED A CHANGE ORDER REQUEST TO THE BOC OF THE FIFD FOR THE ADDITIONAL WORK.

NOW, THEREFORE, BE IT RESOLVED THAT THE BOC OF THE FIFD APPROVES THE CHANGE ORDER AND AMENDS THE APPROVED CONTINGENCY AMOUNT FROM \$30,300 TO \$64,300, WITH THE TOTAL CONTRACT PRICE NOT TO EXCEED \$266,300.
