Management Reports

Marine Update - Mr. Cook updated the BOC. Both boats are running fine. Management continues to work on specs for new mufflers for Munnatawket. The new mufflers would require fabrication and installation with an estimated total cost close to \$10,000. Silver Eel has been up and running for nine days. There have been close to 100 online bookings to date. At this time there are five daily commuters each way. Management continues to explore different travel times to accommodate passengers. Mini schedules will be made available when the schedule is finalized.

Property - Commissioner Burnham reported that the contract between Walsh Park and BD is close to being signed. Work is scheduled to commence one week after the contract is signed. Mr. Cook reported that Hay Harbor renters have arrived at 357 Whistler Avenue. Mr. Murphy reported that a few items need to be finalized for the TOS rental permit application which has to be completed by August 1, 2019. Commissioner Burnham reported that several people have commented on the pile of metal that is near the airport. Mr. Hubert was granted permission to fence the area off and hide it approximately 18 months ago, but it has not been done yet. Mr. Murphy will be meeting with Mr. Hubert this week and will bring the matter to his attention. Commissioner Rugg inquired about the status of the airport hanger. Mr. Cook responded that there were some issues with the language of the agreement and has asked attorney Finnegan to clear up the matter with Town Attorney Duffy. Mr. Murphy reported that Friends

of the Fishers Island Theater signed a lease agreement for the 2019 season. Management is working with BD regarding a replacement smoke sensor for the theater.

Airfield Electrical Vault Rehabilitation Award

Resolved to authorize management to review and authorize change orders up to \$42,450 (15%); the total cost not to exceed \$325,450; and it is further

Resolved to authorize management to execute contract and ancillary documents for this project after review by District and Town counsel.
