Finance Committee - Mr. Coleman and Mr. Cashel thanked management and the BOC for setting up the Finance Committee and commends the BOC and management for doing a fantastic job. Observations and recommendations were expressed to the BOC with regard to revenue and expenses including map-

ping out a program for the next 10 years, getting the airport in the positive, getting rentals to earn a market rate of return and developing a business plan for Silver Eel. Mr. Coleman has suggested that a minimum of 10% return is needed on all assets. Discussion ensued among the BOC and Finance Committee members regarding the Fishers Island Ferry assets including the boats, the airport, the theater, rentals and undeveloped lands, as well as, current partnerships with Walsh Park and Lighthouse Works. Continued discussion occurred regarding Silver Eel and the auto ferries rates and schedules.

Management Reports

Marine Update - Mr. Cook updated the BOC and reviewed the traffic report for July. Passengers and Commercial traffic were up 2% and 12% respectively compared to 2018. Mr. Cook reported that the boats are running fine. The new mufflers for Munnatawket are on order and still unsure if they will be installed before the yard period.

MV Silver Eel Update - Mr. Cook reported that Silver Eel was pulled out last week for service. Both water pumps were changed and new props will be put on tomorrow. Silver Eel moved 526 passengers in June 2019 and 1,167 in July 2019. In addition, there were 13 charters in July 2019. Continued efforts are being made to advertise the charter service via social media platforms and email blasts.

Airport - Mr. Ahrens reported that that he has had two conversations with Bruce Hubert regarding ways to increase revenues at the airport, as well as, the reason for the increased rent due to new assessment of property taxes. Chairman Ahrens has agreed to facilitate a future meeting with Mr. Hubert, himself, Mr. Cook and Mr. Murphy to discuss matters of the airport. Mr. Cook informed the BOC that minor changes were made to the hanger lease including a date change and a name change of Bravo 39 LLC to Fishers Island Airways LLC. Mr. Murphy reported that the runway lights will remain off from dusk to dawn throughout the fall.

Property - Mr. Cook informed the BOC that 357 Whistler Avenue house will be getting painted in August. In addition, there has been some repair work to the rental space of Tom Ravino at Mosquito Hollow. Mr. Murphy reported that he will be working with Attorney Finnegan with regard to the property management agreement.

Insurance - Mr. Murphy reported that management reviewed all the policies that they were supposed to and in the fall, management will look at the property more closely, as well as, other hard assets. An engineer will be arriving on September 16 to look at the boats and some of the infrastructure.

HR - Mr. Murphy reported that Kathleen Neiman's last paycheck will be delayed by 2 weeks due to an oversight.
