Minutes of the Meeting of the Board of Commissioners Fishers Island Ferry District December 30, 2019

Chairman Ahrens, at the Fishers Island Community Center, called a meeting of the Board of Commissioners of the Fishers Island Ferry District ("the Ferry District") to order on December 30, 2019 at 10:00 AM.

Commissioners Heather Burnham and Dianna Shillo were present. Also in attendance were Geb Cook, Gordon Murphy and Deanna Ross. RJ Burns, Jon Haney and Kasia Asmolov were present via phone. Members of the public included Chris Dollar and John Ski. Commissioners William Bloethe and Peter Rugg were absent.

Chairman Ahrens established that a quorum was present. Everyone in attendance pledged allegiance to the flag.

Correspondence/Public Comment – Mr. Cook reported that several letters were received regarding the airport hangar. The BOC has agreed to discuss these later in the agenda with other airport matters. Chairman Ahrens expressed his gratitude to all present for their flexibility in changing the meeting time to 10am today due to travel requirements. Mr. Chris Dollar expressed two comments regarding airport operations. Mr. Dollar stated that last summer there were numerous runway incursions with pedestrians and cyclists that is posing a safety risk. Mr. Dollar has suggested more aggressive signage and management has agreed and will implement. Other suggestions made were trail cameras and fencing. Mr. Dollar's second concern was the lighting that has had issues for two years. Currently there is no nighttime flying. Mr. Murphy responded that the issue is being worked on. Baseline King, who will be doing the work on the electrical vault, has visited and will most likely start in March. Mr. Murphy intends to identify an electrician from BD who can be trained on the intricacies of the airport lighting. He is hopeful that Baseline King will resolve the runway lighting issues.

Management Reports

Marine Update - Mr. Burns updated the BOC. Silver Eel has been hauled out for the winter. The crew removed the hydraulic rams for servicing last week. There was suspicion of a leak in the power heads of the outboard engines that the crew is troubleshooting. Mr. Burns spoke with the Fairhaven shipyard today. MV Munnatawket is running behind schedule; however is being re-floated this afternoon. Last week the USCG approved all the welds. Painting of the lazarette continues. The bow thruster had a seal leak while at the yard that was corrected last week. All the work items have been completed except for the operational test of the bilge manifold. Mufflers have been installed and there seems to be less engine noise in the cabin. We will have a better sense once the boat is back in the water. Mr. Burns is expecting the ferry to return from the shipyard sometime next week. Once returned, the crew will need two weeks for in-house work list items, but the ferry will be available if needed. After Munnatawket is in service, MV Race Point will be pulled from service for approximately one week for dockside maintenance. Mr. Cook reported that he spoke with Keith Nielson from Docko on Friday, December 27th regarding moving forward with alternative dredging options since there has been little movement with regard to the Suffolk County dredging opportunity. Mr. Cook continues to reach out to Suffolk County Legislator Al Krupski. After discussion with Keith, Mr. Cook believes that there could be a cost saving if one of the dolphins on the west side were moved to allow for two small barges to be moored and then allow a truck onto the barge to load and unload. Mr. Cook will move forward with the RFPs. \$100,000 of bond money has been set aside for the dredging project. Mr. Cook also reported that New London Seafood would be ramping up after January 1, 2020 when certain fish species quotas will be increasing. Commissioner Burnham has requested monthly revenue reports from management for this partnership. Mr. Cook has agreed to provide them.

Fare Update - Mr. Cook reported that the public hearing that was originally scheduled for today has been pushed to the end of January since implementation has been moved to March 1, 2020. Discussion ensued regarding the new reservation fees and whether to continue peak and off peak rates or single pricing. Management will look into the implementation of a two-tier fee, gather more data, and push to have the information at the next BOC meeting so a decision can be made.

Theater Update - Mr. Murphy reported that management will have a draft RFP for review at the next BOC meeting.

Airport - Mr. Murphy updated the BOC. With consultation with the FAA and C&S, there has been agreement to extend the timeframe of the runway-paving project so the Ferry District does not have to absorb all the costs in one year. Other projects include the design for the repair and repaving of the airport access road and the slope down into the parking area. In addition, one of the District's goals is to work on the sea wall internally with ferry staff. Mr. Cook reported that he was copied on correspondence sent to Willard Soper of the ICB from the Burr's and Esser's regarding the proposed airport hangar, expressing their points of concern with the site plan. Discussion ensued. It was noted that the BOC held a public hearing on the proposed hangar on May 29, 2018 and Mr. Cook presented the hangar proposal to ICB on May 25, 2019. No questions or concerns were raised at either of these meetings. Mr. Cook responded to Mr. Soper.

Airport

It is further RESOLVED to authorize management to execute the 2020-2025 ACIP non-binding data sheets and forward them to the FAA.

Pursuant to N.Y. Labor Law § 203-e, an employee who feels that his/her rights in this regard have been violated may bring a civil action in court and can seek remedies including an award of damages, injunctive relief, reinstatement and/or liquidated damages."
