### **Management Reports**

Marine Update - Mr. Burns updated the BOC. The USCG is using both boats to practice boarding while coming alongside the boats. This is necessary in the event of an emergency where the USCG would need to board the vessels. The M/V Race Point re-power is moving along. An electrical engineer will be visiting to evaluate the switchboard capacity on Race Point. On March 16, 17 and 18, 2020, M/V Munnatawket will be at Goodison Shipyard for structural modifications. Three days were blocked in the event of weather delays; however, work should only take one day. The New London Fire Department will be visiting sometime this month. The NLFD's confined space rescue team will perform this exercise annually so that the NLFD can become familiar with the boats and crew. Orsted Wind Farm plans to modify New London State Pier in a two-year rehab project. This is where the ferry has their heavy weather mooring. As a result, Mr. Burns and Mr. Haney have been diligent in looking at other locations and piers in the area for heavy weather mooring and they are hopeful that an agreement can be reached in the near future. A brief discussion occurred regarding the recent article posted on the Fishers Island website regarding the possible closure of the USCG Station on Fishers Island. Mr. Burns will look into it and report to the BOC at the next meeting.

**IT -** Mr. Murphy updated the BOC. The District has secured Atlantic Broadband to provide a second internet service to the New London terminal. This will allow for increased Wi-Fi at the terminal and to have everything moved to the cloud. This work should be completed by the end of March. Mr. Murphy reported that Microsoft sunsetted Windows 7 in the first week of January 2020. The District has five PCs with Windows 7. Four PCs will be replaced. Mr. Murphy also reported that updating of the ticketing software is moving ahead.

**Airport** - Mr. Murphy updated the BOC. Construction is scheduled to begin the week of March 23, 2020 for the upgrade of the lighting and electrical vault building and systems. Annual burning of surrounding lands has been on hold due to wind.
