Chair Ahrens called a meeting of the Board of Commissioners of the Fishers Island Ferry District (the "Ferry District") to order on May 28, 2024 at 4:00 PM at the Island Community Center and via Zoom.

Commissioners Ace Ahrens, Heather Burnham, Tom Cashel, Jim Reid and Dianna Shillo were present. Also in attendance were Geb Cook, Dave McCall, Jon Haney, Carol Murphy and Deanna Ross. There were no members of the public present.

Chair Ahrens established that a quorum was present. Everyone in attendance pledged allegiance to the flag.

**Correspondence/Public Comment** - Mr. McCall reported that he received a letter from Nate Chaves outlining a proposal for the art exhibition at the bunker on June 15, 2024. Mr. Chaves stated he has obtained insurance and there would be no permanent change to the bunker. The BOC asked that management clarify his insurance to cover liability, as it only stated medical. The BOC supports upon this contingency.

Correspondence was received from Mr. Ian Lockey requesting a year round residency card. Mr. Lockey has been on Fishers Island since March 2024 and plans on living here through the winter. Mr. McCall stated that he received his application today. The BOC approves after a 4 month waiting period per policy.

Mr. McCall reminded all that the ferry elections will be taking place on Tuesday, August 13, 2024. Commissioner Ahrens will be stepping down.

An email was received by Mrs. Jane Ahrens requesting a special boat to pick up the blood drive phlebotomists at 3:45 or 4:00 pm on Tuesday, June 4, 2025. The BOC approves and Mr. Haney stated this would not be a problem and Commissioner Ahrens will respond to Mrs. Ahrens.

Marine Update - Mr. Haney updated the BOC. The Fire Suppression System has been installed on both the Race Point and Munnatawket. Pressure test will happen in June. Munnatawket has its annual inspection this Thursday and Race Point next Tuesday. Mr. Haney spoke with the broker today regarding the sell of Silver Eel, and there has been no new news but still has 2 people interested from Alaska. Silver Eel has been charted for the crew from B&W Paving at \$650 per trip.

Mr. Cook reported that the RFP for ferry design is complete and he will share with the BOC and the Town Attorney. This RFP is to hire a naval architect for the design of the new boat. Mr. Cook also reported he is working on a grant for the new ferry. It is focused on diesel which is still considered the most efficient from a cost stand point; however, will still consider hybrid. R-99 fuel would lower emissions.

Mr. Cook reported that Internet is now on the Race Point and the address and password is posted. Munnatawket will be up and running next week. Management will publish on various platforms when both boats are finished.

Mr. Cook shared the reservation manifest from last Friday. There were only a few who made multiple reservations. Discussion ensued and management will continue to work out the issues and add more inventory when needed.

**Other -** Mr. Cook asked the BOC if there is need for an informational meeting regarding the USCG building before June 4, 2024. The BOC has agreed to have an information session this Thursday, May 30, 2024 at the Community Center.

Mr. McCall reported that a walk around of leased properties will take place June 3, 2024 from 9am-11am. This will include both management and the BOC.
